Advertising:

MILITIA VOX's name and/or likeness will appear in all ads connected with the event(s) named in the agreement. The correct ARTIST billing, applicable for all promotional and advertising materials, is:

Accommodations:

If hotel rooms are required, they must be prepaid (including all taxes, required gratuities, parking, etc.), located at the venue hotel and reserved under the BUYER's name. Hotels must be quality- 3 star or higher ONLY. Early check-in and/ or late check out may be required. **2 Non-smoking double-queen rooms should be reserved.**

Security:

The PURCHASER shall guarantee proper security at all times to ensure the safety of MILITIA VOX, auxiliary personnel, instruments, all equipment, costumes, personal property, the stage, back stage, bathrooms, vehicles, parking areas, all exits and entrances to the auditorium, mixing consoles and merch areas. Security protection is to commence upon arrival of MILITIA VOX at the venues, until all equipment is repacked into transportation and MILITIA VOX and their personnel have left the premises. PURCHASER will not allow stage access to audience members. PURCHASER is responsible for loss, or damage to equipment, personnel, or vehicles due to inadequate security, or an unruly audience. PURCHASER will be responsible for any insurance coverage (liability, workers' comp. etc.) naming MILITIA VOX as additional insured. It is the sole responsibility of the PURCHASER to pay 100% of damages within 30 days of occurrence.

Artist Guest List:

The PURCHASER shall not limit the ARTIST to fewer than FIVE (5) guests.

Sound:

MILITIA VOX will not be bringing a PA to the event. We will require a qualified audio technician to run the sound. Please have all sound equipment including the sound system and accessories (sound boards, microphones, speakers, cables, etc.) and all backline instruments and amplifiers present and fully operational no later than 2 hours before the scheduled event start time.

Merchandise:

The ARTIST shall have the exclusive right to sell goods (including, but not limited to, compact discs, dvds, items of clothing and other novelty promotional items) on the premises of the place of performance. Unless requested by PURCHASER, the ARTIST will not offer merchandising at private or corporate events. PURCHASER agrees to provide an accessible secure, clean, well-lit, and highly visible area suitable for merchandise sales. The ARTIST may opt to offer fans an autograph signing session on purchased merchandise after the performance, which will require up to 60 minutes of merchandising time.

Hospitality

If hospitality is contracted, catering is required in dressing room or other suitable area after sound check. The following options should be provided to ARTIST, free of charge:

Six (6) x hot, healthy meals with vegetarian options.

Suggestions include: Deli tray (with bread and condiments), chicken, low fat hot entrée, salads, fruit, veggies...

1 x Case of room temperature bottled water, non-sparkling

1 x Case of cold beer on ice

1 bottle of Jack Daniel's Tennessee Whiskey OR 1 bottle of Bombay Sapphire Gin

A selection of snacks, ie: chips, cheese & crackers, nuts, fruit, etc.

A selection of juice, soft drinks.

Coffee and hot water for brewing tea, if possible.

A selection of cutlery, cups, etc.

6 x large clean towels

OR Buyout of \$20.00 USD in the US or \$25 Euro in Europe or \$25 or 305 MXN pesos in Mexico, per person.

MILITIA VOX- Technical Rider

If we are flying to the event...

If we are flying to the event the PURCHASER will need to provide backline equipment. This gear can either be rented or borrowed, but either way it should be professional grade, fully functioning, and in good condition.

Backline Gear

Drums:

Please provide a high quality maple kit with the appropriate mounting hardware for tom toms-

1. 22" bass drum

2. 16" floor tom

3. 12" tom tom

4. 14" x 5" OR 16" x 6" snare drum (wood, no metal please)

Heavy duty hardware (DW, Yamaha, Tama or equivalent) 5. 1 snare drum stand

6. 1 Hi hat stand + Clutch

7. 3 Cymbal stands (boom type, not straight)

8. 1 Double bass drum pedal (DW 5000 or DW 9000)

Artist will provide his own cymbals.

Guitar Amps:

1. Electric guitar TUBE amp- Mesa Boogie preferred or Marshall only, please

2. Electric Violin TUBE amp- ENGL amp preferred or Marshall and a DI

Bass Amp:

1. Bass rig- 8x10 cabinet with a 500 to 1000 watt bass head. SVT, Ampeg or GK.

Synth/Keyboards:

1. Dual keyboard stand (a stand for 2 keyboards) and 2 DIs Artist will provide our own keyboards.

Microphones:

- 1. Artist will need 1 lead vocal mic with a straight stand, round base preferred.
- 2. 1 backing vocal mic with a boom stand.

A selection of well-maintained microphones, stands, DIs, cables, etc... Shure SM58, Audix OM6, Sennheiser E935 or equivalent.

MILITIA VOX - Technical Rider Technical Information

Front of House

Mixer

Must have at least 24 channels with XLR inputs, 4 pre- fader auxiliaries, and phantom power. Please have a graphic EQs set up on the mains and monitors at mix position.

Personnel

Please have a qualified audio technician present before, during, and after the event. Also, we will need 2-3 people to help with load in and load out.

Monitors

Monitor checks shall be done after a line check has been done on all channels. This is the quickest and most efficient way for us to do monitors. We will need 4-6 wedges. Ideally, 3 across the front, 2 in the middle to either side and 1 in the back for drums. If 6 monitors cannot be provided, 3 across the front and 1 in the back for drums is sufficient.

WARRANTIES AND REPRESENTATIONS

1. Should the PURCHASER cancel this engagement under any circumstance, other than an act of nature, four (4) weeks before

the performance, the PURCHASER shall immediately remit to the ARTIST's REPRESENTATIVE, a certified check or money order in the amount of fifty percent of the full price specified for the performance.

Should the PURCHASER cancel this engagement under any circumstance, other than an Act of God, two (2) weeks before the performance, the PURCHASER shall immediately remit to the ARTIST's REPRESENTATIVE, a certified check or money order in the amount of one hundred percent of the full price specified for the performance. If the PURCHASER cancels the engagement, the PURCHASER will also incur full financial responsibility for all non-refundable flights, hotel accommodations, vehicle rentals, and any other fees related to the performance. MILITIA VOX agrees to furnish PURCHASER with receipts for travel and hotel costs upon request. If ARTIST is rescinding party, all monies paid prior to the date of cancellation will be refunded. Any "rain date" will be negotiated and written apart from this agreement.

2. The ARTIST's obligations hereunder are subject to detention or prevention by sickness, inability to perform, accident, failure of means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, any act of public authority, or any other cause, similar or dissimilar, beyond their control.

3. This agreement shall be construed in accordance with the laws of the State of New York and shall be deemed entered into in that State. If an attorney is retained for the purpose of collecting compensation agreed to herein, or for any other litigation concerning MILITIA VOX and the event herein, purchaser agrees to pay for the reasonable cost of such attorney's fees.

4. In case of any conflict of terms, the terms contained within this Rider shall prevail over all others. All terms of this Rider are specifically accepted by the PURCHASER unless they are waived by the ARTIST or their representative. Such waiver shall be effective only if written consent is given by the ARTIST or their representative.
